Dear Ms. Kitchings:

This correspondence is in response to Mr. Taylor's "Motion to Strike 100% False Footnote From Respondents' Brief." Please be advised that in the first sentence of Footnote No. 4 of Respondents' Initial Brief, Respondents inadvertently referred to Odell Morton's deposition testimony as opposed to Reginald Morton's testimony. The specific sentence reads: "Appellant contends that the circuit court's reliance on Odell Morton's deposition testimony was prejudicial error because Appellant was denied the right to cross-examine Morton." (See Resps. Initial Br. p.8, fn. 4). This was an obvious typographical error, as the remaining portion of the footnote clearly speaks to Reginald Morton's deposition and discusses the fact that Odell Morton was not deposed in the case.

Pursuant to Rule 211(b)(2), Respondents will correct the obvious typographical error in their Final Brief by amending the first sentence of Footnote No. 4 to state: "Appellant contends that the circuit court's reliance on *Reginald* Morton's deposition testimony was prejudicial error because Appellant was denied the right to cross-examine Morton." This correction should resolve Mr. Taylor's Motion.


