The above mentioned case originated as a claim of overpayment by SCDHHS after auditing 29 patient records. The evidence presented included office notes (over a thousand pages), detailed claim reports, HC Pro forms all having names of patients, and or medicaid ID numbers, and totals over three thousand pages. The ruling of Chief Officer Mr. Robert French details each patient's initials and Medicaid ID number, as well. In order to comply with the Health Insurance Portability and Accountability Act, to protect the patients from stolen identity, or disclosure of their medical information, and to prevent lawsuits to either respondent and petitioner for exposure of private medical and insurance information, I hereby request the Clerk Of Court to consider sealing the documents from SC Office Of Hearings and Appeals, SC Administrative Law Court, SC Court Of Appeals, and those at the Supreme Court relating to this case, that include patient's name, and/or medicaid ID numbers. The patients expect the parties to protect their information, it could be harmful to patients and parties to expose it. Thus, the public health and safety is best served by sealing the documents.
