




Ms. Kitchings,

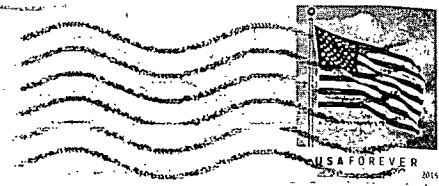
