NOTICE OF APPEAL

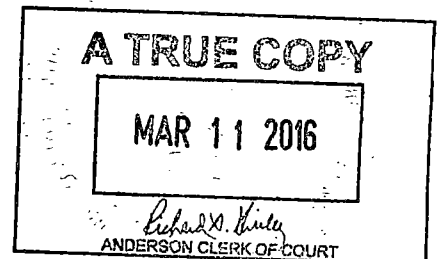


