Dear Ms. Kitchings:

On February 12, 2016 the parties to the above-referenced appeal informed the Court that they had reached an agreement on settlement terms to resolve the underlying action. Therefore, they requested the appeal be dismissed without prejudice and asked for the Court to hold the remitter for 30 days while settlement was consummated. The Court obliged and issued an Order dated February 19, 2016 that dismissed the appeal and notified the parties that it would hold the remitter for 30 days from the date of the order. The Order went on to state that "[i]f the parties notify the Court before 30 days have passed that they could not finalize the settlement, the appeal will be reinstated upon request."



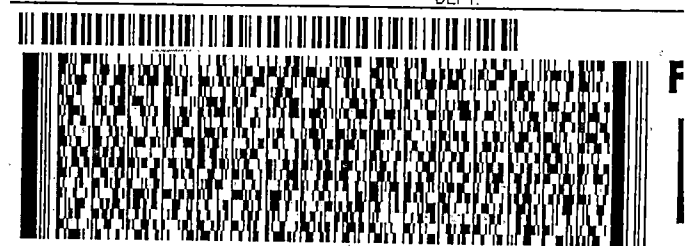
