At a Court of General Sessions, convened on October ¹⁴ 2015, the Grand Jurors of Charleston County present upon their oath:


FAILURE TO REGISTER AS A SEX OFFENDER

The defendant, Daniel Maurice Frasier, having been convicted of an offense for which he is required to register as a sex offender pursuant to SC Code Section 23-~~3~~^{3*}-430, did on or about May 1, 2015, in Charleston County, South Carolina, fail to register as a sex offender with the Charleston County Sheriff's Office and/or fail to notify the Charleston County Sheriff's Office of a change of address, change of employment, or of attendance, enrollment, employment, volunteer status, intern status, or vocation status at any public or private school, such being a second offense. This is in violation of Section 23-3-470 of the South Carolina Code of Laws (1976) as amended.
