JOINT NOTICE OF APPEAL


SCENT LAND HOLDINGS, LLC; South Carolina ENT, Allergy, and Sleep
Medicine, P.A.; Amy Puchalski; and Dr. Robert Puchalski (collectively, "Appellants"),
by and through undersigned counsel, hereby appeal the Orders of the Honorable

DeAndrea G. Benjamin (“Judge Benjamin’s Orders”) and the Honorable Diane S. Goodstein (“Judge Goodstein’s Orders”).

Judge Benjamin’s July 31, 2012 Order granted Respondent’s Motion for Summary Judgment against SCENT Land seeking dissolution of the company. Judge Benjamin’s Order denying Appellants’ Motion to Alter or Amend Judgment was entered on February 1, 2013 and Appellants received written notice of entry of this order on February 14, 2013. Appellants appealed Judge Benjamin’s Orders (Appellate Case No. 2013-000448) and the parties subsequently filed an agreement seeking a dismissal of the appeal without prejudice. Pursuant to the Honorable John Cannon Few’s August 21, 2013 Order, this matter is ripe for review and is properly before this Court. Accordingly, Appellants now appeal Judge Benjamin’s Orders.

Appellants also appeal the judgment of Judge Goodstein’s Order and also from the order denying their Motion to Alter or Amend and for Reconsideration of that judgment. Judge Goodstein’s Order was filed December 8, 2015 and Appellants received written notice on December 9, 2015. Appellants timely filed a Motion to Alter or Amend and for Reconsideration on December 17, 2015 which Judge Goodstein denied in a written order filed on February 24, 2016. Appellants received written notice of the entry of this Order on February 25, 2016. A copy of the Orders referenced in this Joint Notice of Appeal are attached.




