COUNT ONE:

That JOHN CALVIN SLEDGE did in Greenville County, on or about the 29th day of January, 2014, unlawfully and with malice aforethought kill KIMBERLY SLEDGE by means of shooting her in the head, and that KIMBERLY SLEDGE died as a proximate result thereof. This is in violation of §16-3-10 of the South Carolina Code of Laws (1976) as amended.

COUNT TWO:

That JOHN CALVIN SLEDGE did in Greenville County, on or about the 29th day of January, 2014, possess or visibly display a pistol during the commission or attempted commission of a violent crime, to wit: murder. This is in violation of §16-23-490 of the South Carolina Code of Laws (1976) as amended.
