Michael Fuller had a jury trial and was found guilty on the charge(s) of Possession of stolen pistol, Possession of weapon during a violent crime, Unlawful carrying of a pistol and Kidnapping. Mr. Fuller was sentenced on February 19, 2016 before the Honorable G. Thomas Cooper, Jr. in Aiken, South Carolina.

A timely motion to reconsider was filed and served. The motion to reconsider was granted in part and denied in part. The defense received a copy of the Order on March 23, 2016.

Mr. Fuller appeals his conviction and sentence. Mr. Fuller also appeals the court's failure to find that the Kidnapping conviction did not include a criminal sexual offense, requiring him to register as a sex offender.


