The basis of my appeal is I was only given 36 hours notice before my court appearance. I had no time to prepare myself or do ANY research in regards to the definition of "Assault and battery of a high and aggravated nature". My Attorney never informed me that "Act of injury which resulted in great bodily injury or act was accomplished by means likely to produce death" was the verbiage. Mrs. Mauldin Did NOT require ANY Medical Attention. She did get a medical exam.. 10 days later and NO injuries were found. NO Broken nose? →

I was led to believe that I would get time served (6 months) and maybe some probation. I was working 2 jobs and had another very good job offer and just wanted to put this All behind me or I would have NEVER pled guilty. I have a witness to what Mr Floyd told me on our last meeting in regards to my plea. Her statement to police does NOT line up with the medical reports.

6 years ... NO Medical Attention required
NO Blood... NO Eye damage...

NO Split Lip... NO injuries Found.

IS NOT "Assault and Battery"



