REQUEST FOR EXTENSION



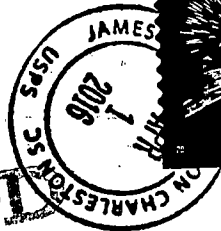
