MOTION TO REQUEST OUT OF TIME PERMISSION FOR AN EXTENSION OF TIME
IN WHICH TO FILE INITIAL BRIEF

Appellant, Alton Chisolm, moves out of time, for an extension of time in which to file Appellant's initial Brief. Counsel states that on February 1, 2016 he advised the court he was appointed by the South Carolina Office for Appellate Defense, to represent Appellant in this action. On February 8, 2016 counsel received a letter from the Court of Appeals directing appellant to file its initial brief within thirty (30) days from that date. 

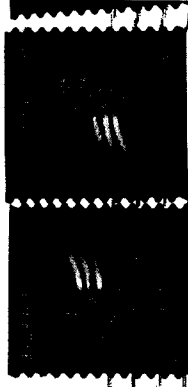
