
Notice of Intent to Appeal





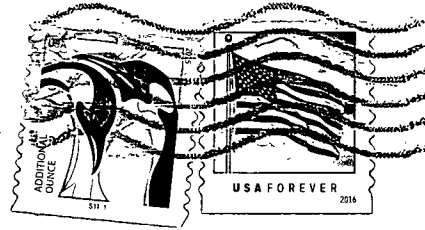
