MOTION OF RESPONDENT/APPELLANT
FOR EXTENSION OF TIME TO FILE ITS
INITIAL REPLY BRIEF OF RESPONDENT/APPELLANT

Respondent/Appellant Branch Banking and Trust Company, Successor
in Merger to Branch Banking and Trust Company of SC, a/k/a BB&T
("BB&T"), respectfully moves for a 15-day extension of time in which to file
their Initial Reply Brief of Respondent/Appellant. In support of this motion,
BB&T would show as follows:

1. On March 17, 2016, BB&T filed and served its Initial
Respondent's Brief of Respondent/Appellant and Amended Designation of

Matter. On the same day, Appellant/Respondent Skywaves I Corporation (“Skywaves”) filed its Initial Respondent’s Brief of Appellant/Respondent and Designation of Matter.

2. Undersigned counsel received a copy of Skywaves’ brief from co-counsel late in the afternoon on Monday, March 21.

3. Pursuant to Rule 208(a)(3), SCACR, BB&T’s Initial Reply Brief of Respondent/Appellant is due within 10 days after service of Skywaves’ Brief, *i.e.*, March 27, 2016. Because March 27 is a Sunday, under Rule 263(a), SCACR, the deadline is automatically moved to the next business day. Accordingly, BB&T’s Initial Reply Brief is presently due on March 28, 2016.


4. On March 24, 2016, Skywaves requested BB&T’s consent to an extension of 15 days for the filing of Skywaves’ Reply Brief, making Skywaves’ new deadline Tuesday, April 12. BB&T has consented to this request.

5. In order to keep the briefing for these cross-appeals on the same schedule, BB&T respectfully requests that the time for filing its Reply Brief likewise be extended for 15 days, to Tuesday, April 12, 2016. Additionally, this extension is necessary in light of the upcoming Easter holiday and impending deadlines in other cases.

6. BB&T’s counsel have consulted with counsel for Skywaves and are authorized to state that Skywaves consents to the relief requested in this motion.

WHEREFORE, BB&T respectfully requests that the deadline for filing its Initial Reply Brief of Respondent/Appellant be extended 15 days, to Tuesday, April 12, 2016, or to such other date as the Court may set.


