

Request for Extension of Time to Request Transcript of Trial

Dear Mr. Hall:

In accordance with our conversation this morning, I am providing this letter requesting a fifteen day extension to request the trial transcript for the appeal in the above case. It is my understanding that the request for the trial transcript is due today, April 4, 2016. I was scheduled to see Ms. Price today at 1:00 p.m. at the Camille Graham Correctional Facility to have her complete and sign the Affidavit of Indigency. When I arrived, I was informed that Camille Graham was placed on "lock down" and that my visit was cancelled. My office called Camille Graham in an attempt to reschedule my visit to see Ms. Price tomorrow morning, April 5, 2016. We were told however, that the "lock down" status is a decision that is made by headquarters and may remain for an indeterminate period of time. For these reasons, I am requesting a fifteen day extension instead of the ten day extension we discussed in our conversation this morning. As indicated below, I am faxing a copy of this letter to the Office of Appellate Defense for their information.
