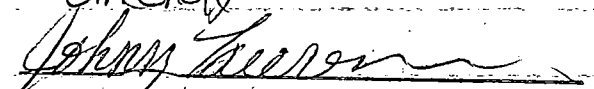
Dear Mr. Fain
