
Upon receipt of the letter from the Court of Appeals Clerk dated April 4, 2016 in the above-captioned matter, and noting Rule 207 SCACR, Appellant Lauren Murphy moves this Honorable Court to extend the deadline for requesting the transcript of the proceedings under appeal from March 21, 2016 to March 23, 2016, the date Appellant sent a formal request for the trial transcript to Court Reporter Deborah Garrison regarding the September 10, 2015 hearing before the Honorable Judge Gravely. 
