

**DUI LESS THAN .10, 3RD OFFENSE**

The defendant, Richard Lee McClinton, did on or about October 30, 2015, in York County, drive a motor vehicle while under the influence of alcohol and/or any other drug or a combination of drugs and/or substances which cause impairment to the extent that the defendant's faculties to drive were materially and appreciably impaired and while having an alcohol concentration of less than .10%, such being at least the third offense within a period of ten years including and immediately preceding the foregoing date, all in violation of Section 56-05-2930(A), *Code of Laws of South Carolina* (1976, as amended).
