23 Q Who is that?

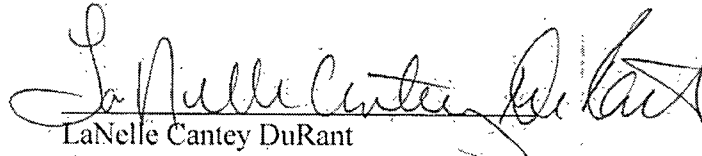

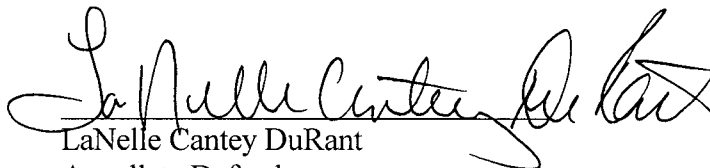
