This is to acknowledge that on April 11<sup>th</sup>, 2016, I received your letter requesting the Transcript of Record in the above matters. I have reviewed my records and estimate that the transcript will be approximately 38 pages.

Rule 607 provides that the rate of \$3.25 shall be charged per page for a copy of a transcript. Based on the current rate, the estimated cost will be \$130.00 (\$158.50 if e-mailed). If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.
