
MOTION FOR PERMISSION TO ORDER TRANSCRIPT


WHEREFORE, Appellant moves for an order of this Court allowing him to order a transcript of the Appellate Panel hearing, outside the time set by Rule 207(b).





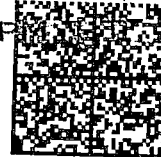
