

**SECOND CONSENT MOTION FOR EXTENSION

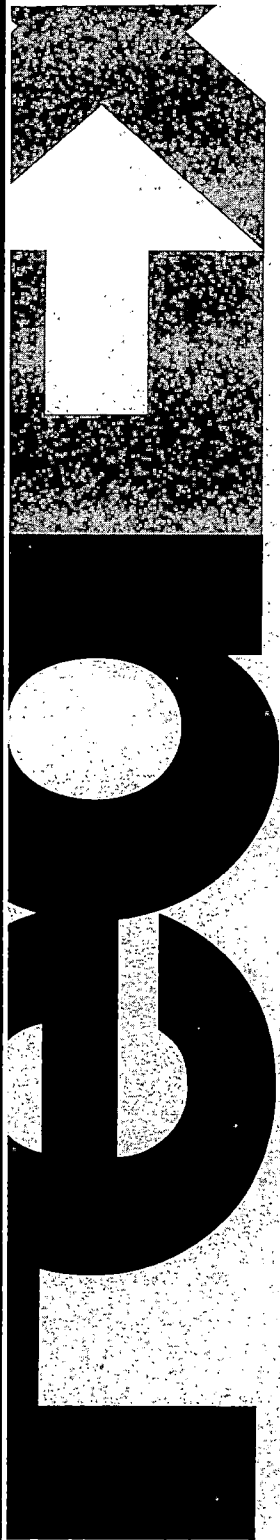

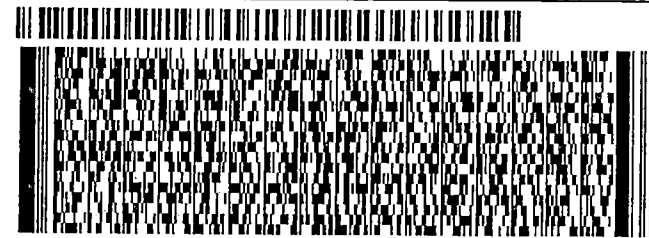
