AFFIDAVIT OF HILTRUD STEIMEL

Case No. 2015-001869

I, Hiltrud Steimel, being of lawful age, qualified and competent to testify to, and having firsthand knowledge of the following facts, do hereby swear that the following facts are true, correct and not misleading:

Plain Statement of Facts

1. On July 24, 2015, a Final Foreclosure Hearing was held in the Offices of the Master of Equity, Beaufort County, The Honorable Marvin H. Dukes, III. Present were:
On behalf of Plaintiff: Ashley Wheeling-Goodson, Esq., of Rogers Townsend & Thomas, of Columbia, South Carolina
On behalf of Defendants: Hiltrud Steimel, Pro Se, of Bluffton, South Carolina
2. As the hearing concluded, Judge Marvin H. Dukes asked Ms. Wheeling-Goodson, for the wet-ink, blue signature copy of the Note. She proceeded to place a document on the table.
3. During this hearing, I was under considerable distress due to a family emergency with my 89-year-old mother in Germany. I noticed that the signature on the Note was off and while it was a blue signature, it was not what would have been on the original Note. I was emotionally too ill and in a hurry due to an emergency call with my mother's brother who had consulted with her doctors in the hospital in Germany and who was going to report to me. I left immediately. Later on I noticed that I had never been shown the complete Note to make sure it was the same as the copy that I had.
4. I am very much concerned about the signature presented and respectfully request the help of the Court to have the redeemed Note produced from the office of the Master in Equity in Beaufort County so an expert analysis can be made to assure the validity of the Note.
5. I apologize to the Court for the delayed request and need to refer again to the emergency with my 89-year-old mother. I am an only child, was 72 years old at the time, and did indeed have to leave on a few hours notice to fly to Germany to be at the bedside of my mother who passed away on October 31, 2015. I had to remain in Germany to liquidate the remaining estate and was not able to return to Bluffton until February, 16 2016.

I thank the Court for his forbearance and his understanding in the matter.
