SHE SAID THAT IS WHERE SHE HAD LEFT THEM AS SHE WAS FLEEING FROM THE RESIDENCE. THE PANTIES WERE COLLECTED BY SGT SMITH AND SUBMITTED INTO EVIDENCE.

Sgt Smith, Why was those pictures taken with the evidence on the bed?

I TRANSPORTED THE MALE SUBJECT TO THE OCSD WHERE HE WAS QUESTIONED BY SGT SMITH AND LT. HAWK. AFTER ABOUT 30 MINUTES, THE MALE SUBJECT SAID THAT HE WAS DONE SPEAKING WITH THEM AND THAT HE WANTED TO SPEAK WITH AN ATTORNEY.

I TRANSPORTED THE MALE SUBJECT TO THE OCDC AND BOOKED HIM IN ON UTT #36540FC FOR DUS 1ST

READ DAY IN REGARDS

DAY IN REGARDS TO THE INTERNET. SHE ADVISED THAT HE ASKED TO SHOW HER SOMETHING IN HIS BEDROOM SHE STATED THAT SHE WENT TO HIS BED ROOM. AMY STATED THAT HE THEN SHUT AND LOCKED THE DOOR. AMY STATED THAT WILBER TOLD HER THAT HE WOULD PAY HER \$50.00 TO HAVE SEX. SHE REPLIED NO. SHE ADVISED THAT HE THEN THREW HER TO THE BED AND TOOK OFF HER PANTS AND UNDERWEAR AND BEGIN TO SEXUALLY ASSAULT HER. SHE ADVISED THAT HE WAS ON TOP OF HER WITH HER ARMS PINED DOWN. SHE STATED THAT WHEN HE WAS FINISHED SHE PUT HER PANTS BACK ON RAN BACK TO HER RESIDENCE AND CALLED 911. AMY ADVISED THAT HER PINK AND WHITE UNDERWEAR WAS STILL AT THE INCIDENT LOCATION.

AMY WAS THEN TAKEN TO THE OCONEE COUNTY MEDICAL CENTER BY FAMILY MEMBERS WHERE A SEXUAL ASSAULT KIT COULD BE COMPLETED. I THEN RESPONDED TO THE OCONEE COUNTY MEDICAL CENTER AND OBTAINED A WRITTEN STATEMENT FORM AMY. A VICTIMS FORM WAS ALSO ISSUED.

I THEN RESPONDED TO THE INCIDENT LOCATION WHERE I MET WITH MASTER DEPUTY MEYAR AND INVESTIGATOR SGT. SMITH. A CONSENT TO SEARCH WAS GIVING BY THE SUBJECT. ~~DURING THE SEARCH OF THE RESIDENCE A PAIR OF PINK AND WHITE UNDERWEAR WAS LOCATED IN THE BEDROOM. IT WAS COLLECTED BY SGT. SMITH TO BE PLACED INTO EVIDENCE.~~ THE SUBJECT WAS THEN TAKEN TO THE OCONEE COUNTY SHERIFFS OFFICE FOR FURTHER INVESTIGATIONS BY MASTER DEPUTY MEYAR. NOTHING FURTHER AT THIS TIME.

SUPPLEMENTAL

I DEPUTY MAYER RESPONDED TO A SEXUAL ASSAULT CASE WITH DEPUTY BEDDINGFIELD. THE FEMALE VICTIM SAID THAT SHE WAS ASSAULTED BY HER NEIGHBOR. DEPUTY BEDDINGFIELD WENT WITH THE VICTIM TO THE OCONEE MEMORIAL HOSPITAL TO HAVE A RAPE KIT PERFORMED ON HER. I STOOD BY AT THE INCIDENT LOCATION (1190 DAVIS MILL ROAD) TO SEE IF THE SUSPECT WOULD RETURN. I SAW A CHEVY BLAZER TURN A RIGHT TURN LIGHT INDICATOR ON AS IT WAS COMING DOWN DAVIS MILL ROAD. THE VEHICLE WAS BELIEVED TO BELONG TO THE MALE SUSPECT IN THE SEXUAL ASSAULT CASE. THE VEHICLE TURNED INTO THE DRIVEWAY JUST BEFORE 1190 DAVIS MILL ROAD. I PULLED IN BEHIND THE VEHICLE AS IT STOPPED IN FRONT OF A RESIDENCE. A BLACK MALE EXITED THE VEHICLE AND STARTED TO WALK TOWARD THE WOOD LINE. I ASKED THE MALE TO STOP AND COME SPEAK WITH ME. I IDENTIFIED THE SUBJECT AS ONE WILBUR ALVESTER RICKMON. I CHECK ON HIS LICENSE CAME BACK AS BEING SUSPENDED. I PLACED THE SUBJECT UNDER ARREST FOR DRIVING UNDER SUSPENSION.

READ THE SUSPECT HIS MIRANDA WARNINGS TO WHICH HE SAID THAT HE WOULD SPEAK TO ME IN REGARDS TO THE SEXUAL ASSAULT CASE WHICH OCCURRED EARLIER. HE TOLD ME THAT HE NEVER TOUCHED THE GIRL AND THAT SHE WAS JUST AT HIS HOUSE TO HELP

1 bedroom door, back to the left, there is -- I call it
2 chest of drawers. Has a mirror on it. Then the bed is
3 over to the right of it. [REDACTED]

5 video, what we call Axon video, where it was laying

9 on the bed and [REDACTED]
10 the underwear whose they were.

11 Q And State's Exhibit 3?

12 A That's the same underwear. It's just laying on
13 the bed.

14 MS. SIMMONS: Your Honor, at this time the State
15 would move 5, 4 and 12 into evidence.

16 MR. DAY: No objection.

17 THE COURT: Admitted without objection.

18 (WHEREUPON, State's Exhibit Numbers 4, 5 and 12
19 were admitted into evidence.)

20 BY MS. SIMMONS:

21 Q Did you find any money with the underwear at the
22 scene?

23 A No money.

24 Q Did you find any money on the floor anywhere in
25 the home?

1 Took.

2 As I come back around, that's when I saw the white
3 and pink polka dotted panties laying on the ground
4 which I was informed was left there, and that's when I
5 asked Mr. Rickmon about them. And through that we
6 collected that evidence and then came to the sheriff's
7 office where I talked to him again and read his rights.
8 Again approximately about 7:16. Spoke to him about it,
9 and then I wrote down the information on a piece of
10 paper of what we call a record of interview sheet.

11 Q Have you reviewed Deputy Mayer's Axon video prior
12 to today?

13 A I'm sorry?

14 Q I'm sorry. Have you reviewed Deputy Mayer's Axon
15 video prior to today?

16 A I have.

17 Q Is it a fair and accurate representation of that
18 day?

19 A Yes, ma'am.

20 (WHEREUPON, State's Exhibit Numbers 4, 5 and 12
21 were marked for identification.)

22 BY MS. SIMMONS:

23 Q I'm going to show you what has been premarked as
24 State's Exhibit 4, 5 and 12. What is this?

25 A That's the chest of drawers. When you come in the
