MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Jeffrey Dana Andrews respectfully requests an extension of thirty (30) days, **until May 31, 2016**, in which to file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter are due to be filed with the Court today.
2. Counsel for Jeffrey Dana Andrews respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time.
3. Counsel filed the petition for writ of certiorari in the death penalty case of Anthony Woods v. State on Wednesday, April 27, 2016 in the Supreme Court. **The appendix was in excess**

of 5,400 pages, and the petition for writ of certiorari was a total of 81 pages. Also, co-counsel was forced to go out on maternity leave ahead of schedule. Counsel has extensive administrative duties as the Chief Appellate Defender, including administrative and Appellate Project oversight, and, training three new appellate defenders and reading all of their writings. In addition counsel now is reviewing applications, and will continue interviewing for another Appellate Defender position since Appellate Defender Benjamin Tripp has accepted another position. On April 27, 2016, counsel also filed the brief of petitioner in the case of State v. Raheem D. King with the Supreme Court. The case of State v. Brett D. Parker promptly came to this office for the petition for writ of certiorari due May 11, 2016. On April 8, 2016, counsel filed the return to petition for writ of certiorari in the case of Vander Davon Meetze v. State with the Supreme Court. On April 6, 2016, counsel filed the initial brief of appellant and designation of matter in the case of State v. David Young with this Court. On March 29, 2016, counsel filed the initial brief of appellant and designation of matter in the case of State v. Elias James Walker with this Court. On March 23, 2016, counsel filed the return to petition for writ of certiorari in the case of Levi C. Wells v. State with the Supreme Court. On March 14, 2016 counsel filed a petition for writ of certiorari to the Court of Appeals in the case of State v. Nathaniel Witherspoon with the Supreme Court. On March 10, 2016 counsel filed a petition for writ of certiorari to the Court of Appeals in the case of State v. Andrew Antonio Clemons with the Supreme Court. On February 25, 2016 counsel filed a petition for rehearing in the case of State v. Ryan P. Deleston with this Court. On February 18, 2016, counsel filed the return to petition for writ of certiorari in the case of Edward Rorecuse Young v. State with the Supreme Court. On February 18, 2016, counsel was co-counsel on the death penalty initial brief of appellant in the case of State v. Luzenski Allen Cottrell that was filed with the Supreme Court. On February 12, 2016, counsel filed


the return to petition for writ of certiorari in the case of David Carmichael v. State with the Supreme Court. On February 8, 2016, counsel filed the petition for writ of certiorari to the Court of Appeals in the case of State v. Don-Survi Chisolm with the Supreme Court. On January 29, 2016, counsel filed a petition for writ of certiorari and accompanying appendix in the case of Samuel Thompson, Jr. v. State in the Supreme Court. On January 25, 2016, counsel filed the petition for writ of certiorari to the Court of Appeals in the case of State v. Harold Bennon Cartwright with the Supreme Court.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel is working first on cases that have been extended three times in an effort to make his caseload more manageable and reduce the number of extensions in the future.


5. Counsel for the Attorney General's office consents to this request shown by signature below.


