APPELLANT'S MOTION FOR EXTENSION TO FILE  
PETITION FOR WRIT OF CERTIORARI AND  
ACCOMPANYING APPENDIX

The Appellant's petition for rehearing in the captioned matter was denied by the South Carolina Court of Appeals on April 22, 2016. The Appellant's position is that the decision of the South Carolina Court of Appeals is in conflict with prior decisions of the South Carolina Supreme Court which may well be the result of novel issues of fact and, perhaps, novel questions of law being presented. Consequently, the Appellant is informed and believes that a petition for a writ of certiorari to the South Carolina Supreme Court is proper in this instance.




Appellant's counsels' wife, mother, and office manager is currently in the process of undergoing an extensive chemotherapy and other treatment for metastatic breast cancer in the bone. The initial chemotherapy phase is scheduled to be concluded by June 7, 2016. 
