Monitor

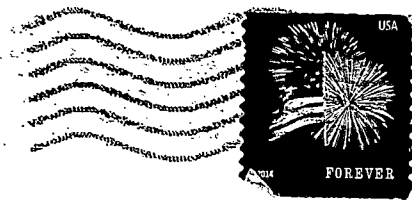
Before My Plece I Tried ~~to~~
