
Wherefore, Respondent contends that this appeal and the interest of justice will be served by granting said Respondent an extension of time; Respondent therefore



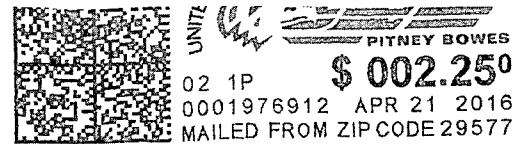
