pursuant to rule 240(e), SCACR, for Return to Motion,


The Respondent moves out of the time, the Court ordered the first

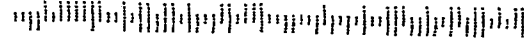



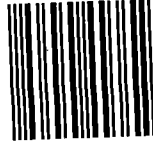
