PETITION FOR EXTENSION OF TIME TO FILE BRIEF OF RESPONDENTS



Norman, pursuant to Rules 208(a)(2), 240, and 263(b) SCACR, petition this Court for an order extending the time to file the Brief of Respondents by 30 days until Wednesday, June 15, 2016. This Petition is the Respondents' first request for an extension, is made in good faith and not intended for delay, and is based on the following grounds:

1. 

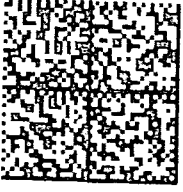
