At a Court of General Sessions, convened on March 16, 2016 the Grand Jurors of Orangeburg County present upon their oath:

TRAFFICKING IN COCAINE, 28 G OR MORE, BUT LESS THAN 100 G OR

That in Orangeburg County, South Carolina, on or about May 23, 2015, the Defendant, Jonathan Jamison, did knowingly sell, manufacture, cultivate, deliver, purchase, or bring into this State, or did provide financial assistance or otherwise aid, abet, attempt, or conspire to sell, manufacture, deliver, purchase, or bring into this State, or was knowingly in actual or constructive possession or knowingly attempted to become in actual or constructive possession of more than 28g but less than 100g of cocaine. This offense in violation of Section 44-53-370 of the South Carolina Code of Laws, as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
