

NOTICE OF APPEAL

The State of South Carolina appeals the post-verdict ruling of the Honorable Frank R. Addy, Jr., with respect to ordering a new trial for Defendant more than two years after his convictions for Burglary in the First Degree and Grand Larceny by a Greenwood County jury, pronounced by written order on May 4, 2016. This notice of appeal is filed pursuant to S.C. Code Ann. § 14-3-330 because the Order is a final judgment vacating the jury's verdict of guilty rendered on March 5, 2014. The State would ask the Court to take notice Rule 246(a) of the S.C. Appellate Court Rules, which stays the May 4, 2016 Order for a new trial and any further proceedings in circuit court.

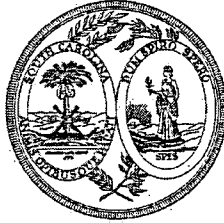

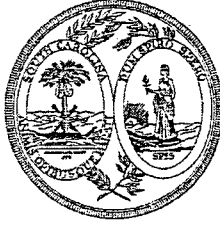
