
**NOTICE OF APPEAL**

Hood: Order of Reference allowing Anita Joye Bethea a/k/a Anita Joy's (the "Respondent") assertion of a violation of the South Carolina Unfair Trade Practices Act to be heard before a jury filed April 28, 2016 (the "First Order") and Order Denying Appellant's Motion to Reconsider filed April May 6, 2016. 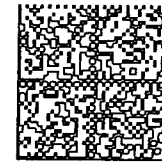
