
**CONSENT MOTION TO HOLD DEADLINES IN ABEYANCE

This appeal is a challenge to the circuit court's issuance of an injunction via order dated May 27, 2015 enjoining the Appellant Robert Taylor from engaging in certain business activities. Yesterday, the parties to this appeal submitted the attached "Consent Order Dismissing Temporary Injunction and Extinguishing Bond Associated Therewith" with the circuit court in order to have the injunction dismissed. (Exhibit A). Dismissal of the injunction will necessarily alleviate the need to continue pursuit of this appeal. Therefore, the Parties respectfully request that the Court hold all outstanding filing deadlines in abeyance for sixty (60) days to allow the circuit court time to dismiss the injunction; and that this appeal be dismissed upon the circuit court's execution of the attached order.



**CONSENT ORDER DISMISSING TEMPORARY INJUNCTION  
AND EXTINGUISHING BOND ASSOCIATED THEREWITH**

On May 27, 2015, the Court entered an Injunction Order in the above-captioned matter temporarily restraining Defendant Robert Taylor (“Taylor”) from engaging in certain activities during the pendency of this lawsuit (“Injunction Order”). The Injunction Order required Plaintiff Coveris Flexibles US LLC (“Coveris”) to post a bond under Rule 65(c) of the South Carolina Rules of Civil Procedure, and Coveris did so on June 2, 2015. On June 22, 2015, Defendants filed a Motion to Reconsider the Injunction Order. On August 19, 2015, an Order was entered denying Defendants’ Motion to Reconsider. Taylor subsequently appealed the Court’s Orders, with such appeal currently pending before the South Carolina Court of Appeals.

Taylor and Coveris desire to avoid further litigation before the Court of Appeals and have reached an agreement—memorialized by this Consent Order—whereby they have agreed to the dismissal of the Injunction Order. Coveris and Taylor agree that this Consent Order is fair, reasonable, and equitable, and does not violate the law or public policy. In the interest of resolving the appeal of this matter, Coveris and Taylor have agreed to the entry of this Consent Order.

Based on the consent of Coveris and Taylor, the Court ORDERS and DECREES as follows:

1. All terms of the May 27, 2015 Injunction Order shall be terminated, effective immediately.

2. Coveris is released fully and immediately from the surety bond filed on June 2, 2015, in compliance with the May 27, 2015 Injunction Order. Western Surety Company, which issued the surety bond, shall similarly be released fully and immediately. No party shall make a claim to recover against the surety bond, as all potential liability thereunder is hereby extinguished forever and fully.
