


WHEREFORE, Defendant prays that this Court will extend the time for filing the Record on Appeal until May 9, 2016.

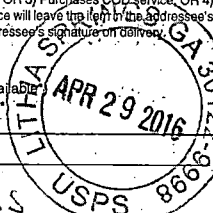
