
PETITION FOR EXTENSION



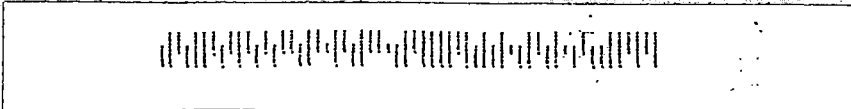

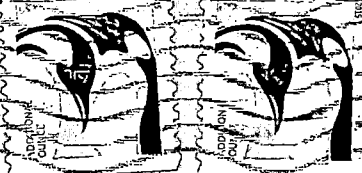
