
Undersigned counsel hereby moves this Court for additional time to allow the Appellant to file any supplemental support for his Notice of Appeal from a guilty plea. As a matter of context, the Appellant was charged and convicted of several offenses including Murder. He was given a life sentence for the Murder and concurrent sentences for the other charges.

Undersigned counsel then appealed the denial of a Motion to Reconsider sentences. In response, this Court ordered undersigned counsel to write the Appellant and inform him of his opportunity to provide any additional support as to the propriety of an appeal of a guilty plea. The deadline for Appellant's *pro se* supplementation is May 9, 2016.





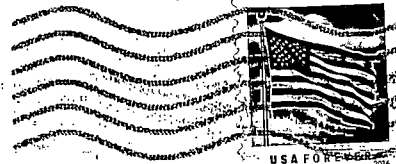
