day extension of time in which to file and serve their Response to Edward Mims' Motion to File Itemized Statement of Costs in the instant case.





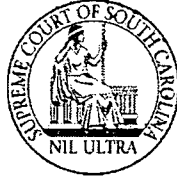
