Counsel for Respondents have been conscientious in their efforts to prepare their response; however, because of the complexity of many of the legal issues attendant in this case





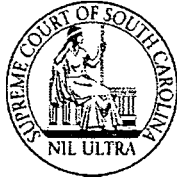
