





Richey Lamont Boyd was indicted for Murder, Possession of a Weapon During Commission of a Violent Crime, Kidnapping, Burglary First Degree, Attempted Armed Robbery, and Conspiracy. After a jury trial, Boyd was found guilty of all five (5) indictments and sentenced on February 16, 2012.

I have not requested the transcript, as it appears that the Office of Appellate Defense may assume representation in this matter. This case was a Rule 608 appointment for me, and Boyd was already in prison serving a sentence when he was indicted for the above charges. I am providing the Office of Appellate Defense with the information they require to assume representation of Boyd.
