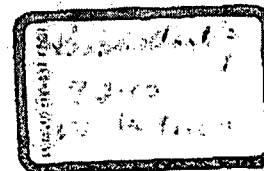

The affiant is an employee with the York County Sheriff's Office and has been since August 1997. The affiant is a certified Police Officer through the South Carolina Criminal Justice Academy and is certified to make arrest and serve warrants.

On March 12, 2006, The York County Sheriff's Office received a complaint from Tabitha Nicole Eford that her father, Darrell Ray Eford has sexually abused her from the age of 4 years old. The Victim stated that at the age of 15 that her family moved to Fort Mill, South Carolina where the abuse continued. The Victim stated that her Mother, Christine Smith Eford was aware of the abuse and made her, Darrell and herself sign a contract in reference to the abuse. The victim stated that her father did use Dildos's and Vibrators on her. The affiant believes that the Dildos's, Vibrators and Documents are located in the home at 111 Wilson Street in Fort Mill, South Carolina. This belief is based on the statements written by the Victim.
