Dear Ms. Kitchings:

Please allow this letter to serve as a response to the Court's letter of August 31, 2012 with regard to the above referenced matter. After having reviewed the Record on Appeal served November 13, 2011, I have determined that all documents identified for inclusion in the Record on Appeal are included in that version of the Record on Appeal.

However, in reviewing the Record on Appeal, I note the following deficiencies in accordance with Rule 210, SCACR:

- Cover Sheet to Record on Appeal is still incorrect -- it appears to be a cross between a state court motion and slip and a Court of Appeals caption. This issue has been addressed by the Court on several occasions. (See letters of October 21, 2011; December 18, 2011 and February 22, 2012);
- The Appellant's Final Brief is still improperly included as part of the Record on Appeal
- Index needs to be corrected as follows:
 - Final brief should be removed
 - "Jury Trial Demand" should actually be "Summons & Complaint"

– Affidavit of Sharon Moody has been excluded from the Index

Finally, there has been no redaction of personal identifiers in the Record in accordance with the Supreme Court Order of August 13, 2007. I note that victim information, addresses and social security numbers have not been redacted in Exhibit A to the Moody affidavit (pp. 25-115) nor in "Appellant's Exhibits" (pp. 150-160).
