# Affidavit of Truth

I along with the facts and evidence presented are true, correct and complete to the best of my knowledge and belief.

I Cindy E. Ramsey swear the following statements to be true:

On June 29, 2011, I and my Aunt, Margaret Lemonds, traveled to York, S.C., to the Moss Justice Center, to obtain records from inmate **Darrell R. Efird's trial and PCR hearing**. We were specifically looking for copies of the signed search warrant, attached affidavits, and of the so called "Hand Written Signed Contract" used as evidence from the search of his home, any papers/drawings the DA used in the PCR Hearing, and anything I thought was of importance to his case.

When going through the Trial File at the Clerk of Court's Office, there was no copy of a signed search warrant and affidavits or the signed written contract. I did find a copy of the letter **Darrel R. Efird, wrote on July 17, 2009**, requesting a certified copy of the "search warrant and affidavit from his case file, case # 2007-GS-46-1992-1996, stating these documents were critical to his PCR proceedings. "See attached Copy". Also attached is the copy of the letter he received back from the General Sessions Division of the Clerk of Court's Office, stating that he would have to contact his attorney James Boyd or Assistant Solicitor Mindy Harvey regarding the search warrant, to which he has written to both.

The nice clerk, "Cindy", said that I might be able to see Mindy Harvey since her office was just upstairs. I thought, "Awesome, since I am here, why not?" With a copy of the letter Darrell R. Efird had written with his request to Mindy Harvey and my Power of Attorney for him, I was made to feel assured that I would finally get him a copy of these items. My Aunt Margaret and I proceeded up stairs to Mrs. Harvey's Office.

A secretary for Mrs. Harvey was notified we were there and came out to assist. She took the letters and my POA back to the office while we waited in the lobby. She returned a little later and stated that they "could not and would not give these items requested to me and that we would have to see the Magistrate's Office downstairs. When asked why, we were told that was what was needed to get these items.

So, off we go downstairs to the Magistrate's Office and spoke to the secretary there. She stated that Judge Benfield was out to lunch and would return in about thirty minutes and that we could come back. She asked who the search warrant was for and wrote down the information to discuss with the Judge upon her return. Aunt Margaret and I then left for the Civil Court House to find the PCR File for Darrell R. Efird.

At the Civil Court House, located at #2 S. Congress St., York, SC, we went to the Clerk of Courts Office to pull Darrell R. Efird's PCR Hearing File. I paid to have the entire contents of

the file photocopied by the staff. I have a receipt #286420, dated 6/29/11, in the amount of \$55.20. In the contents of this file, the only exhibit of a Search Warrant was the copy that Darrell R. Efird supplied the court which, was the unsigned warrant given to him when his house was searched. There was no copy of the Exhibit by Jennifer A. Kinzeler, of the Attorney General's Office, which was presented in court at Mr. Efird's PCR Hearing, which "I" Cindy Ramsey was in attendance at. My question was of course, "Where is it and why it is not in the file?" It was given to the Judge at the hearing. Isn't all material used suppose to be on file?

Next my Aunt Margaret and I went back to the Moss Justice Center to the Magistrates' Office to retrieve a copy of the "Supposed" signed search warrant and affidavits. We were told by the secretary that Judge Benfield could not give us a copy of something she did not sign. I said, "What do you mean? My understanding is that it was signed by Judge Benfield." The secretary once again stated that they could not give me a copy of a search warrant that Judge Benfield did not sign. When I asked her, "Than can you tell me who did sign it?" She responded that she didn't know. Then she told me that they had spoken to Amanda Carter in the Sherriff's Department and she pulled Darrell's file and that we would need to speak to her.

So down the hall we go to meet with Amanda Carter, (the arresting officer as I found out later). Deputy Carter came out into the lobby with NO FILE in hand and asked how she could help us. I explained that we had been sent from Judge Benfield's Office to her in regards to a certified search warrant and affidavits for Darrell Efird. Deputy Carter stated that she could NOT give out that information, that they do not do that. When I told her that it was public information and that I was Darrell's POA, she said again that they do not do that. She said that his Lawyer could request it, or GO SEE THE SOLICITOR, but she could not give it to us. I explained that we had already been to Mindy Harvey's Office, then, too Judge Benfield's and now sent to her. She stated that once again, I would need Darrell's lawyer to request it. (That has been done, why did they think I was there?)

I inquired as to why no one wanted to give us a copy of the so called "signed" search warrant. Being so upset at this point with the run around we were getting, I implied that it was because a signed search warrant did not exist and that the search was illegal and they were trying to cover it up. Because of this an innocent man, wrongly accused and charged is in prison. Deputy Carter of course stated that this was just my opinion and we were done with the conversation.

I was determined to get what I came for and we went back to Judge Benfield's Office to try once more. I explained that Deputy Carter was unwilling to help and wanted to send us to Mindy Harvey's Office, who of course would send us back to the Magistrates' Office and we could do the merry go round all day. Once again I was told by the secretary that they could not give me something that the Judge did not sign. (Note: If you take a look at the search warrant served to Darrell Efird, you will see that it was not signed before being served but was signed when it came back by Judge Benfield) I asked the secretary could she find out who signed it so I could speak with them. She said that there are several magistrates and she did not know which one. WE GAVE UP AND LEFT!!!!

On Friday, July 8, 2011, I called Judge Benfield's Office around 3:30 pm. I finally got to speak with Judge Benfield, who told me that she did not say to her secretary that she did not sign the warrant, but that she did not remember if she signed it because it was so long ago. Again she tried to put me off to Deputy Amanda Carter, who put the search warrant together and served it. I explained to her that she sent me to Deputy Carter while I was there in person and Deputy Carter refused to help me. That I had also been to Mindy Harvey's Office and they sent me to her. I wanted to know why NO ONE involved in this process and case, wanted to give me a copy of the signed search warrant and affidavits when it is suppose to be public record and copies in the trial and PCR hearing files. That from my understanding with the Signed one that mysteriously, showed up the morning of the PCR Hearing and was presented to the Judge, by the Assistant Attorney General, was indeed signed by you, to be executed, and signed it when returned. It is amazing how mysteriously it has also disappeared that the inmate cannot retrieve it from discovery, lawyer, or anyone else he has requested it from, even after the PCR Hearing. Judge Benfield then stated that the files from the trial were kept in the basement and the people that had the keys to the area left at 3:30pm. She would have to wait until Monday, July 11, 2011, to find them and would give me a call. She also stated that she had 200 jurors on Monday and that she did not know what time she would be able to call me. She took my name and phone number down and repeated it to me until she had it correct.

It is Monday, July 11, 2011, and I called Judge Benfield's Office at 3:04 pm, to remind her that the files she needed to look at would need to be found before 3:30 pm due to the people leaving at 3:30 who had the keys to that area. I was told that Judge Benfield was in court and was switched to her message center. I left a message stating that no one would be there after 3:30 to retrieve the files and that I trusted people who said they would call me back to do so. That I would be waiting for her call and I knew she leaves at 5:00 pm. I stated my name and phone number two times, and I also stated that if I did not hear from her today, the she could expect a call tomorrow.

I also stated that I was in attendance at Darrell R. Efird's PCR Hearing, September 2, 2010. The DA asked Mr. James Boyd, who was Darrell's defense lawyer at his trial, who we paid \$10,000 to, and now was testifying for the state, about a signed and unsigned search warrant. Mr. Boyd stated he had BOTH in his file. He had an accordion type file on his lap, while on the witness stand, and was kind of searching/looking for papers when the DA asked, "Did it look like this- the signed search warrant?" and walked over and handed it to Mr. Boyd. He said something about, yes that looks like it. But Mr. Boyd never pulled any papers out form the file on his lap. The DA then showed it to the Judge and to Mr. Rawlinson, Mr. Efird's appointed lawyer, (the one who stated to me in his office in front of my cousin when I asked him what he was going to do about my brother's case... "Born in Rock Hill, Live in Rock Hill, Plan to stay in Rock Hill; yep...that pretty much says it all!) Darrell says he got a brief glimpse of it and it was signed by Judge Benfield and dated the 22<sup>nd</sup> of March 2006. He did not see a date stamp on it like all papers have when processed by the clerk's office. It was handed back to the DA. So why this is then not exhibited as evidence in the PCR File? Why is it that we cannot get a copy of this document? Why is it that it was never forwarded to any of Darrell R. Efird's lawyers by Mr. Boyd, Mindy Harvey, or anyone else when requested? Why did it appear just in time for the PCR Hearing? All good questions no one seems to be able to answer. Was the signature forged or back dated and signed to protect all involved who have covered this up? The PCR

TRANSCRIPT shows that James Boyd states the search warrant was signed giving authorization of search by Judge Benfield on 22<sup>nd</sup> of March 2006. So Judge Benfield, where is it?

I heard back from Judge Benfield on Tuesday, July 12, 2011. She kindly let me know that she could not help and that I would have to file papers for the Freedom of Information Act and that if I needed help I could contact Mindy Lipinski @ [REDACTED] She would be able to walk me through the process. In my frustration, I thanked Judge Benfield and hung up. I called the number she had given me only to reach MINDY HARVEY'S message line. Wow....guess she used to be Mindy Lipinski. I left a message asking that my call be returned. I called again on July 15, 2011, requesting again to have my call returned and help with filing this act. My calls to this day have never been returned.

Here is what I do know form the legal documents that I have read and sitting in on the PCR Hearing. Mr. Efird was served an unsigned search warrant that makes the search illegal. His lawyer Mr. Boyd did nothing about it nor did Mr. Efird know the warrant was illegal until after being incarcerated. He had never been in trouble and does not know the law. However I did not know that a Judge through a PCR Hearing can declare that it was done in good faith, so it stands. You mean a Judge can make something legal even though it goes against the law? The so called evidence was LATE being placed in evidence according to S.C. law, check the documentation. According to the Legal documentation about the "Grand Jury being held in General Sessions Court" which was brought up that it was not by Mr. Efird, and therefore felt that a grand jury did not decide his case, was stated by the Assistant DA at the PCR Hearing that it was held in Common Pleas Court. I believe the laws on the books in SC states that the Grand Jury Must meets in General Sessions Court and Mr. Efird's paperwork states that this is exactly what happened. Well, is the state not required to up hold legal documents that it writes? Yet the DA states it was not and the Judge at the hearing, "I don't care if it happened in the parking lot as long as it happened." What a flagrant disregard for the laws this man is supposed to be supporting!!! I know that Mr. Boyd was asked on the stand where it was he thought he got the unsigned search warrant from. He stated that it could have only come from two places, one being Mr. Efird. He did not list the other place but we all know it would be from the clerk of courts office where he would have sought all information to represent his paying client Darrell R. Efird. Yet Mr. Efird's unpaid appointed Lawyer, Mr. Rawlinson, did not pursue the questioning any further. Why did he not ask Mr. Boyd where it is that he thought Mr. Efird got the search warrant that Mr. Efird gave him? Why did he not ask Mr. Boyd what was the other place the unsigned search warrant would have come from? Oh... Born in Rock Hill, Live in Rock Hill...that is right. Why is it that Mr. Efird wasn't informed by his lawyer James Boyd in the first place that the search warrant was not signed?

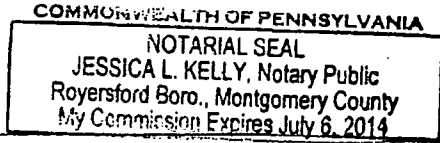

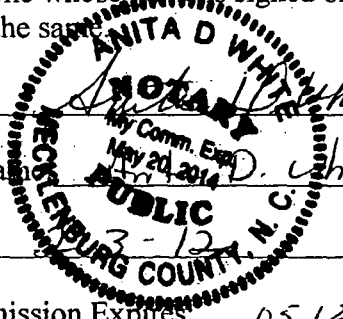


