**PETITION FOR EXTENSION TO FILE
INITIAL BRIEF OF APPELLANT AND
DESIGNATION OF MATTER**

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Trico D. Thompson v. State in the Supreme Court on September 20, 2012. Counsel filed the record on appeal in the case of State v. Connie Dumas in this Court on September 19, 2012. Counsel had a bond hearing in Dillon in the case of State v. Bentley Collins on September 17, 2012. Counsel filed the record on appeal in the case of State v. Marquis Breeland in this Court on September 14, 2012. Counsel filed the record on appeal in the case of State v. Cedric Flood in this Court on September 13, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Nathaniel Caldwell, III v. State in the Supreme Court on September 11, 2012. Counsel had an oral argument in this Court in the case of State v. Derek Maner on September 10, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Darrell Gleaton v. State in the Supreme Court on September 4, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ronnie Middleton v. State in the Supreme Court on September 4, 2012. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Joseph Graddick in this Court on August 28, 2012. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Derringer Young in this Court on August 16, 2012. Counsel participated in the reconstruction hearing in the case of Tonnie Baldwin v. State on August 16, 2012 in Bamberg, South






