RESPONDENT'S MOTION FOR COSTS


Respondent, Brannon Poe, CPA, LLC, hereby moves, pursuant to Rule 222, SCACR, for the taxation of costs on appeal against Appellants Steve Stravolo, Stravolo & Company, P.A. and Upstate CPAs, P.A. f/k/a Mathur & Co., P.A.

Rule 222 provides that "costs shall be taxed against the appellant when the appeal is dismissed or judgment on appeal is affirmed" Rule 222(a), SCACR. By Order filed May 11, 2016, judgment on appeal was affirmed.

As evidenced by the attached Itemized Statement of Costs, the Respondent has incurred taxable costs in the amount of \$225.70. Additionally, the Respondent is entitled to recover an attorney's fee in the amount of \$1,000.00, as authorized by Order of the South Carolina Supreme Court.



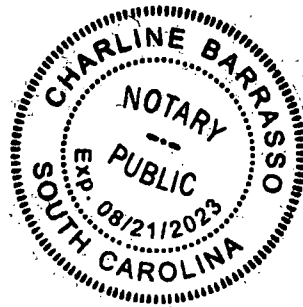
