MOTION FOR EXTENSION OF TIME TO FILE RESPONDENT'S INITIAL BRIEF AND DESIGNATION OF MATTER





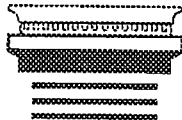
