At a Court of General Sessions, convened on April 29, 2016, the Grand Jurors of Hampton County present upon their oath:

Assault and Battery of a High and Aggravated Nature

That in Hampton County, South Carolina, on or about August 22, 2015, the Defendant, Ebony Evelyn Castro, did cause "Great bodily injury" to the Victim, Sandra Singleton, and/or that the act involved did or was likely to cause great bodily injury to the Victim, to wit: the Defendant was involved in a fist fight with the Victim and then the Defendant pulled out a sharp object and cut the Victim's ear nearly severing it from the Victim's head and causing the Victim to lose a high volume of blood that could have resulted in death and/or resulted in permanent disfigurement or protracted loss or impairment of the function of the skin and/or ear, all in violation of Section 16-3-600(B)(1) et al. of the Codes of Law of South Carolina.
