
**Respondent's Motion to Allow Mary Elizabeth Bolt Campbell to Withdraw as



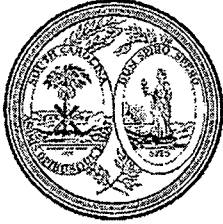
