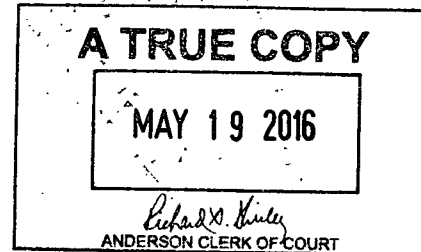

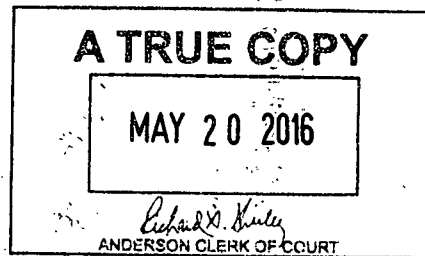

**Arson/Arson- Third degree**

**Count One:** That Edrick Norris Perego did in Anderson County, on or about June 5, 2014, willfully and maliciously cause an explosion and/or set fire to and/or burn and/or cause to be burned and/or aids, counsels, or procures a burning that results in damage to a building, or any other property whether the property of himself or another, which resulted in damage to a building belonging to Robert Bannister located at 4018 Whitehall Road Ext. in Anderson, South Carolina. This is in violation of 16-11-110 of the *South Carolina Code of Laws (1976)*, as amended.

**Count Two:** And the Grand jurors of Anderson County, South Carolina, do further present upon their oath that That Edrick Norris Perego did in Anderson County, on or about June 5, 2014, willfully and maliciously cause an explosion and/or set fire to and/or burn and/or cause to be burned and/or aids, counsels, or procures a burning that results in damage to a building, or any other property whether the property of himself or another, which resulted in damage to a building belonging to Robert Bannister located at 4020 Whitehall Road Ext. in Anderson, South Carolina. This is in violation of 16-11-110 of the *South Carolina Code of Laws (1976)*, as amended.
