I, **GAIL T. LEWIS**, a resident of and domiciled in the County of Lexington and State of South Carolina, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking all Wills and Codicils at any time heretofore made by me.

ITEM I

ITEM III

I give and bequeath all of my personal and household effects of every kind except those specifically devised herein, including but not limited to furniture, appliances, furnishings, pictures, silverware, china, glass, books, jewelry, wearing apparel, boats, automobiles, and other vehicles, and all policies of fire, burglary, property damage, and other insurance on or in connection with the use of this property, to my husband, **STEPHEN L. LEWIS, SR.** In the event that **STEPHEN L. LEWIS, SR.** is not available, I give, devise and bequeath my personal property to my son, **LLOYD CARSON LEWIS.**

If my issue do not agree to the division of the said property among themselves, my Personal Representative shall make such division among them, the decision of my Personal Representative to be in all respects binding upon my issue. I request, but do not require, that my Personal Representative and my issue abide by any memorandum by me directing the disposition of this property or any part thereof. The cost of packing and shipping such property shall be charged against my estate as an expense of administration.
